## Application for Membership

## CLASSES OF MEMBERSHIP

**Resident Member.** A Resident Member classification shall be those members with permanent residence located in Scott County, Iowa, Rock Island County, Illinois, or any contiguous county, and upon election to membership shall pay an initiation fee, and annual dues as established by the Board of Directors for this class.

Non-Resident Member. A Non-Resident Member classification shall be those members with permanent residence located outside of Scott County, Iowa, Rock Island County, Illinois, or any contiguous county, and upon election to membership shall pay an initiation fee, and dues as established by the Board of Directors for this class. In the event a Non-Resident Member shall move to Scott County, Iowa, Rock Island County, Illinois, or any contiguous county, he or she shall become a Resident Member, and shall pay annual dues for this

Junior Member. A Junior Member classification shall be those members that are under the age of thirty-five (35) as of July 1st, and upon election to membership shall pay an initiation fee, and dues as established by the Board of Directors for this class. Once a Junior Member reaches the age of thirty-five as of July 1st, he or she shall become a Resident or Non-Resident Member based on their permanent residence and shall pay annual dues for this class.

Seasonal Member. A Seasonal Member classification shall be those members that are residents of Iowa or Illinois, but do not physically reside there four (4) or more months each fiscal year, and upon election to membership shall pay an initiation fee, and dues as established by the Board of Directors for this class. Seasonal Members are limited use of the club facilities from July 1st thru October 31st, and from April 1st thru June 30th each fiscal year.

**Primary Corporate Member.** A Primary Corporate Member classification shall be those members of a bona fide business enterprise that meet such requirements as shall from time to time be determined by the Board of Directors. Each Corporate Membership shall have one (1) Primary Corporate Member and at least one (1), but no more than five (5) Associate Corporate Members. The Primary Corporate Member may transfer the related Associate Corporate Member to another employee of the Primary Corporate Member no more than once per fiscal year except in the event of death or termination of employment. Upon election to membership shall pay an initiation fee, and annual dues as established by the Board of Directors for this class.

Associate Corporate Member. An Associate Corporate Member classification shall be those members who are officers or employees of a Primary Corporate Member and upon election to membership shall pay dues as established by the Board of Directors for this class. There shall be no initiation fee for this class. In the event an Associate Corporate Member is no longer an officer or employee of the Primary Corporate Member, he or she shall become a Resident, Non-Resident, Junior, or Seasonal Member based on member class requirements, and shall pay annual dues as established by the Board of Directors for this class.

Membership Dues. All members shall pay annual membership dues to the Corporation in such amounts and in such manner as the Board of Directors determines from time to time. Membership Dues are due and payable by one of the options set forth below. Payment of dues other than the total amount by the 1st day of July may have additional fees as determined by the Board of Directors. One (1) payment of the total amount by the 1st day of July each year. In two (2) equal semi-annual installments by the 1st day of July and January. In four (4) equal quarterly installments by the 1st day of July, October, January, and April.

A) Resident membership

D) Seasonal Membership – Iowa or Illinois Residence but not for at least 4 months of the year Resident of Iowa or Illinois, but do not physically reside there four (4) or more months each fiscal year limited use of the club facilities from July 1st thru October 31st, and from April 1st thru June 30th each fiscal year.
